Size of the Corporate Compliance Profession: It's Complicated

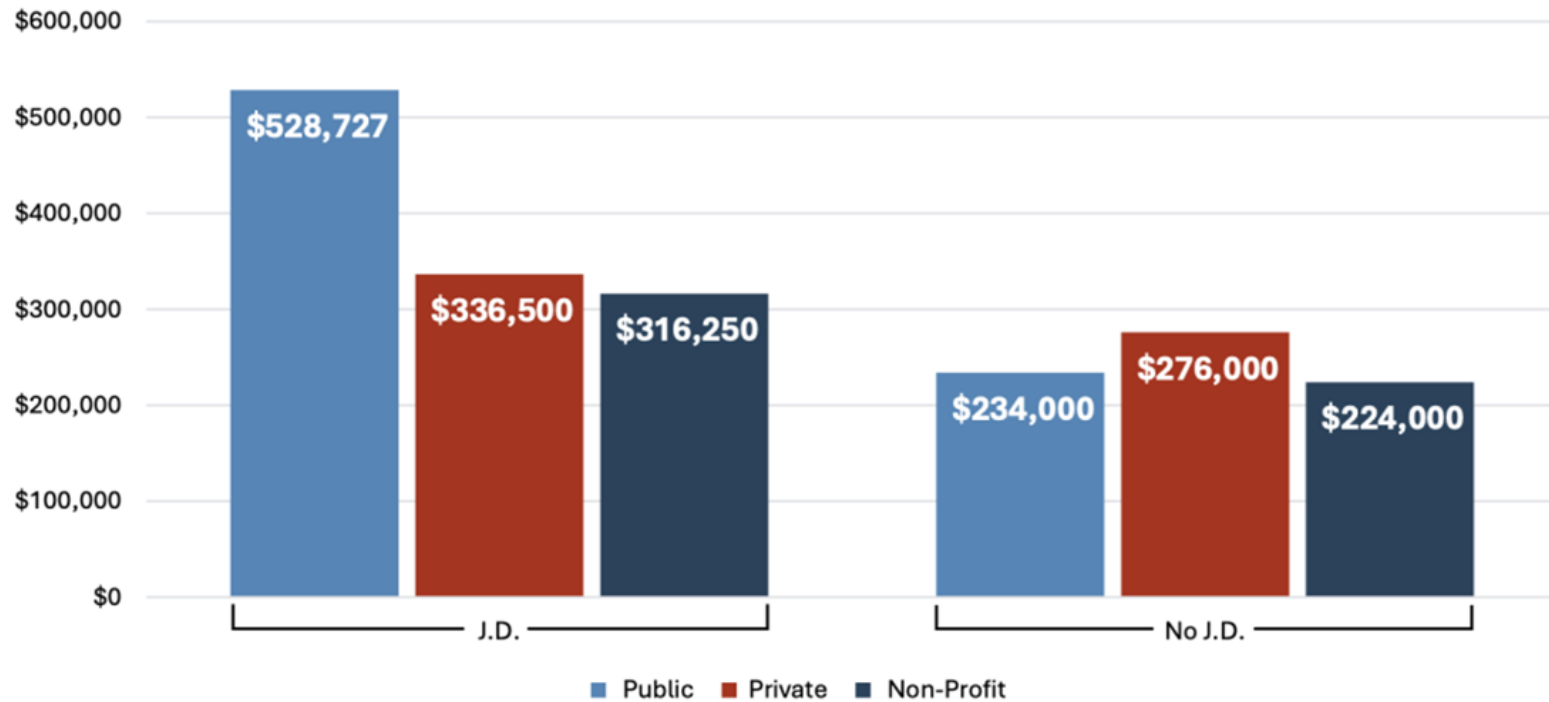


Bureau of Labor Statistics offers a partial sense
